In JNPT, one post of **Sr. Dy. Chief Medical Officer** in the pay scale of **Rs. 80000-220000** will fall vacant w.e.f. 01.11.2021 and it has been decided to fill up this post as per the JNPT Employees (Recruitment, Seniority and Promotions) Regulations, 2011(as amended on 11.12.2017).

The said post will be filled by composite method of recruitment i.e. through promotion/transfer/deputation on absorption basis of the officers from Major Ports, fulfilling the criteria of eligibility prescribed in the schedule of JNPT Employees (Recruitment Seniority & Promotion) Regulations, 2011(copies attached at Annex-I).

The selection will be by merit, for which the bench mark in the overall grading in the ACRs should not be below "Very Good".

You are requested to circulate the above vacancy among the eligible officers of your Port. The applications (in the prescribed proforma) of suitable and willing officers of your Port who satisfy the eligibility criteria as prescribed at Annex-I, may be forwarded along with the following documents so as to reach the undersigned on or before **3rd September, 2021**. NOTIFICATION

New Delhi, the 11th December, 2017

G.S.R. 1502(E).—In exercise of the powers conferred by Sub-section (1) of Section 124, read with Section (1) of Section 132 of the Major Port Trusts Act, 1963, (38 of 1963), the Central Government hereby approves the Jawaharlal Nehru Port Trust Employees (Recruitment, Seniority and Promotion) Amendment Regulations, 2015 made by the Board of Trustees for the Port of Jawaharlal Nehru as set out in the Schedule annexed to this Notification.

2. The said Regulations shall come into force on the date of publication of this notification in the Official Gazette.

SCHEDULE

Jawaharlal Nehru Port Trust

Jawaharlal Nehru Port Trust Employees (Recruitment, Seniority and Promotion) Amendment Regulations, 2017

In exercise of powers conferred by Section 28 of the Major Port Trusts Act, 1963 (38 of 1963), the Board of Trustees of Jawaharlal Nehru Port hereby makes the following regulations further to amend the Jawaharlal Nehru Port Trust Employees (Recruitment, Seniority and Promotion) Regulations, 2011, namely :

1. Short Title and Commencement :

- (i) These Regulations may be called the Jawaharlal Nehru Port Trust Employees (Recruitment, Seniority and Promotion) Amendment Regulations, 2017.
- (ii) They shall come into force on the date of publication of the approval of the Central Government, as required under the provisions of Sections 124 and 132 of the Major Port Trusts Act, 1963, in the Gazette of India.

2. In the Jawaharlal Nehru Port Trust Employees (Recruitment, Seniority and Promotion) Regulations, 2011, in the Schedule, under the Medical Department :-

- (1) for the post of Senior Dy. Chief Medical Officer at serial No.4, the provisions under column No. 8 shall be substituted as under:-

"Essential:

- i) MBBS Degree from a recognized University.
 - ii) A Post Graduate (PG) Medical Degree or PG Medical Diploma in the specified specialty from a recognized University.
 - iii) Post qualification experience of 10 years in case of PG Degree holders and 12 years experience in case of PG Diploma holders in the relevant field of specialization in a reputed hospital."
- (ii) for the post of Chief Medical Officer at serial No.5, the provisions under column No. 8 shall be substituted as under:-

"Essential:

- i) MBBS Degree from a recognized University.
- ii) A Post Graduate (PG) Medical Degree or PG Medical Diploma in the specified specialty from a recognized University.
- iii) Post qualification experience of 16 years in case of PG Degree holders and 18 years experience in case of PG Diploma holders in the relevant field of specialization in a reputed hospital."
