1. Technical Officer on Contract (Cat.1): A First-class Engineering Degree (Full time) in Computer Science / Electronics & Communication with minimum 60% marks in aggregate from any recognized Institution / University with minimum one-year post qualification experience in the field of embedded firmware development, design & development of frontend applications and expertise in C, C++, IBM BPM tools.

Candidates having experience in Qt development environment, web administration and having knowledge in computer software development life cycle will be preferred.

2. Technical Officer on Contract (Cat.2): A First-class Engineering Degree (Full time) in Electronics & Communication with minimum 60% marks in aggregate from any recognized Institution / University with minimum one-year post qualification experience in the field of installation & maintenance of Electronic equipment preferably CCTV, Security gadgets, Access control systems, Computers, Servers & Networking etc.

3. Technical Officer on Contract (Cat.3): A First-class & Full-time M.Sc. / Engineering Degree in Electronics & Communication / Computer Science / Information Technology or MCA with minimum 60% marks in aggregate from any recognized Institution / University with minimum one-year post qualification experience in the field of software development (Android & Web) in intranet, internet and mobile applications by using any of JAVA, .Net, ColdFusion, HTML, JavaScript, CSS technologies.

Knowledge in RDBMS design & tuning concepts and international certifications in any of above technologies will be an added advantage.

4. Junior artisan on Contract: Should have passed ITI (2 years) in the trades of Electrical / Electronics / Instrumentation with minimum one-year post qualification experience in the field of Electronic instruments, CCTV System, Security gadgets, Access control systems and Physical protection system etc.

5. Junior Translator on Contract (Official Language): A First class Master Degree in Hindi / English / Translation Studies with minimum 60% marks in aggregate from any recognized Institution / University. The candidate should possess English or Hindi as main subject at Degree Level plus Recognized PG Diploma or Certificate course in translation from English to Hindi and vice-versa with knowledge of Bilingual (Hindi and English) word processing on computer. IV. SELECTION METHOD:
