9. The candidate who is already in government service shall submit '**No Objection Certificate**' from the present employer at the time of Interview.
10. Canvassing of any kind will lead to disqualification.
11. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.
12. Private practice of any type is prohibited.
13. The appointee shall not be granted any claim or right for regular appointment to any post of AIIMS.
