**Job Responsibilities**



The project requires extensive travel towards the conduct of trainings, pilot testing of modules, liaison/co-ordination with other Central/State/Ministries/Depts./Agencies. Specific job responsibilities of the posts are as under.

- To assist in all technical components of the project implementation.
- To develop and test modules/ tools for promotion of DDT alternatives for vector control.
- To assist in the implementation of the training program under this project.
- Contribute in training/capacity building of the health care personnel at National/State/District levels.
- Preparation of scientific/technical matter for website development and its update.
