With campuses at Mumbai (main) and off-campus at Tuljapur, Guwahati and Hyderabad, TISS offers over 50 Post Graduate programmes, 18 Doctoral programmes, and 3 Under Graduate programmes in a range of socially relevant interdisciplinary and applied social science disciplines, and over 30 BVoc programmes. The TISS Tuljapur Campus was established in 1987 with the goals of promoting sustainable, eco-friendly and equitable socio-economic development of rural communities. Through its programmes, TISS Tuljapur seeks to contribute to the revival of the rural economy, society, and polity by encouraging alternatives in development. In order to achieve this, TISS Tuljapur has evolved a four dimensional programme comprising teaching, training, field action and research & documentation. It has built a strong team of multidisciplinary faculty drawn from social work, philosophy, sociology, economics, agriculture, anthropology, psychology, geography and other related disciplines. Presently, it conducts a five year Integrated BA-MA Programme in Social Sciences and MA in Social Work in Rural Development.

The Institute invites online applications for '**Counsellor**' to be filled at **TISS, Tuljapur Off-Campus**. The post will be on Contract Basis for a period of one year and extendable based on performance of candidate and requirement by the Institute.

Remunerations: Consolidated Salary @ Rs 40,000/- to Rs 45,000/- p.m.

Educational Qualification:-

- Master's Degree in Clinical Psychology/Counselling/Counselling Psychology or Master's in Social Work in Counselling with at least 55% aggregate marks from a recognized University and
- Minimum of 5 years of work experience of counselling of which at least 2 years experience of counselling Bachelor's/Master's students in college/university.
- Must have proficiency in English, Hindi and Marathi Language.

Last date for submission of online applications will be 30 January 2022.

Date of interview: The eligible candidates will be communicated by an e-mail and mobile phone to appear for the interview to be conducted at TISS, Mumbai campus.

Application fee: The application fee of Rs. 1000/- be paid on-line. The application fee for SC/ST/PWD candidates will be Rs. 250/- if they attach the required certificate to the online application form. The women applicants are waived from the payment of application fees. The application will be valid only on receipt of the application fee, if applicable. Fees once paid shall not be refunded under any circumstances.

Other Conditions:-

- The Institute reserves the right to relax qualifications of the candidate based on the work experience and to relax age in the case of persons already holding comparable positions in a University/Research Institution of repute.
- The Institute reserves the right to invite persons for interview who may not have applied for as per the above procedure and not fill up the vacancy advertised.
- Since applications received may be short listed, merely possessing the prescribed qualifications and the requisite experience would not entitle a person to be called for interview.
- The post is unreserved, but candidates belonging to reserved category can apply.
