
You are requested to circulate the above vacancy among the eligible officers of your Port. The applications (in the prescribed proforma) of suitable and willing officers of your Port who satisfy the eligibility criteria as prescribed at Annex-I, may be forwarded along with the following documents so as to reach the undersigned on or before **4<sup>th</sup> March, 2022**.

- 1) Photo copies of the ACRs of the applicant for the last 5 years.  
(attested by the officer not below the rank of Dy. HOD on each page)
- 2) Copies of disclosure certificates of attached ACRs.
- 3) Attested Photo-copies of all certificates.
- 4) Vigilance & Administrative clearance of the concerned Port.

The cutoff date for determining the eligibility shall be last date of receipt of application.

The administrative Ports shall ensure that the applications of the candidates will be forwarded to Jawaharlal Nehru Port Trust with the prior approval of the Competent Authority and with all requisite documents before the date of closing. In case of receipt of advance copy of application in respect of any applicant by the Port, candidature of the candidate would not be considered if his/her application is not received within 15 days of the last date of receipt of applications

Once the application(s) is/are forwarded in respect of any employee with the prior approval of the Competent Authority, the concerned Port shall ensure that he/she would be relieved immediately in any case within 30 days of his/her present post in case of selection and appointment to post.

**G.S.R. 662(E).**—In exercise of the powers conferred by Sub-section (1) of Section 124, read with Sub-section (1) of Section 132 of the Major Port Trusts Act, 1963 (38 of 1963), the Central Government hereby approves the Jawaharlal Nehru Port Trust Employees (Recruitment, Seniority and Promotion) Amendment Regulations, 2016 made by the Board of Trustees for the Port of Jawaharlal Nehru and are set out in the Schedule annexed to this Notification.

The said Regulations shall come into force on the date of publication of this Notification in the Official Gazette.

**SCHEDULE****Jawaharlal Nehru Port Trust****Jawaharlal Nehru Port Trust Employees (Recruitment, Seniority and Promotion) Amendment Regulations, 2016**

In exercise of the powers conferred by Section 28 of the Major Port Trusts Act, 1963 (38 of 1963), the Board of Trustees of the Port of Jawaharlal Nehru hereby makes the following regulations further to amend the Jawaharlal Nehru Port Trust Employees (Recruitment, Seniority and Promotions) Regulations, 2011, namely :-

**I Short Title and commencement.-**

(i) These Regulations may be called as the Jawaharlal Nehru Port Trust Employees (Recruitment, Seniority and Promotion) Amendment Regulations, 2016.

(ii) They shall come into force on the date of publication of the approval of the Central Government as required under the provisions of Section 124 and 132 of the Major Port Trusts Act, 1963 in the Gazette of India.

**II In the Jawaharlal Nehru Port Trust Employees (Recruitment, Seniority and Promotion) Regulations, 2011, in the Schedule, for post of Deputy Chief Vigilance Officer under the Vigilance Department.—**

(i) the entries under Column No. 11 shall be substituted by the words, "By deputation".

(ii) the entries under Column No. 12 shall be substituted by the following :

"Deputation from officers of Major Port Trusts holding analogous posts or officers holding posts in the pay scale of Rs.20600-46500 (Rs. 10750-16750 pre-revised) with 3 years regular service in the grade in Major Port Trusts failing which from officers of the Central Govt./ State Govt./PSUs/Autonomous Bodies with similar grade."
