1. COMPANY PROFILE:

Maharashtra State Electricity Transmission Company limited (MAHATRANSCO), a wholly owned corporate entity under the Maharashtra Government, was incorporated under the Companies Act, in June, 2005 after restructuring the erstwhile Maharashtra State Electricity Board to transmit electricity from its point of Generation to its point of Distribution. It owns and operates most of Maharashtra's Electric Power Transmission System. MSETCL operates a transmission network of 49,813 Circuit KM of transmission lines and 706 EHV Substations with 1,33,583 MVA transformation capacity. This infrastructure constitutes most of the inter regional as well as intra-regional electric power transmission system in the State. Today, MSETCL is the largest state transmission utility in the country.

- 4.2 A Degree should be from a University or Institute in India, established or incorporated under Central Act or a State Act or any other qualification recognized as equivalent thereto.
- 4.3 The candidate have to acquire above qualification on or before <u>24.05.2022</u>. If candidates acquire above qualification after <u>24.05.2022</u> and secured place in merit list as per marks obtained in written test, he will not be considered as eligible for the post/selection.

- 5.3 The upper age limit for Persons with Disability (Divyang) is relaxable up to 45 years.
- 5.4 The upper age limit for candidates applying against Sports Quota is relaxable by 5 years but should not be more than 43 years in any case.
- 5.5 The upper age limit for departmental candidates (only MSETCL Employees) is 57 years.
- 5.6 Date of birth as per SSC/School Leaving Certificate should be mentioned in the Application Form. The age will be considered as on **24.05.2022** i.e. last date of submission of the application.

6. **RESERVATION:**

- Caste Certificate issued by Competent Authority of GoM. Further, on selection, they will have to submit copy of Caste Validity Certificate issued by the Caste Scrutiny Committee if available with them. - 6.2 The Caste Certificate issued by appropriate Competent Authority of Maharashtra State shall only be considered as valid for availing the benefit of reservation including application fees.
- 6.3 The candidates applying for the post **should be domicile of Maharashtra State**. Backward Class candidates should be of the categories notified by the Maharashtra State viz, (a) Scheduled Caste (including SC category person who has adopted Baudha Religion) (b) Scheduled Tribes (c) VJ-A, NT-B, NT-C, NT-D (d) Special Backward Class and (e) Other Backward Class.
- 6.4 In case of documents which are obtained as and when it is required like Non-Creamy Layer Certificate (NCL), Domicile Certificate etc., the candidate, at the closing date of receipt of application, should have a proof of submission of his / her application to the appropriate authority for issuing such documents / certificates. However, the candidate will have to produce the original documents / certificates at the time of physical verification of the documents / certificates by the Company, failure to produce the same may lead to become disqualified.

- 6.9 The reservation policy for **Divyang** shall apply as per State Government directives. Persons suffering from not less than 40% of disability shall only be eligible for the benefit of reservation for Divyang. - 6.10 There shall be 1% horizontal reservation for Orphan as per the provision prescribed in महिला व बाल विकास विभाग, महाराष्ट्र शासन, शासन निर्णय क्र. अमुजा-२०११/प्र.क्र.२१२/का-३ दिनांक ०२.०४.२०१८. The orphan candidates who desire to avail the benefit of Orphan reservation will have to submit **Orphan Certificate** (अनाथ प्रमाणपत्र) and **Domicile Certificate** of Maharashtra State issued by the Competent Authority of GoM.
- 6.11 The desired candidates, should claim the benefit of reservation i.e. Social, Women, Sports Person, Orphan and Divyang etc. clearly and absolutely in online application form itself. If not claimed, it shall not be considered at any stage later on.
- 6.12 Once the caste is notified in application form, it cannot be changed at any stage later on. The Backward Class candidates who apply against Open category will not be permitted to change the option once exercised at any stage later on.

- 6.13 Those reserved category candidates who have applied against Open category & compete with the Open category candidates will be treated as Open category candidate for the purpose of recruitment/selection process. However, if any such departmental reserved category candidate who have entered in MSEB / MSETCL by taking the benefit of reservation earlier, he/she will have to submit the caste certificate & caste validity certificate from Competent Authority before appointment, if selected even though he/she may be applying under Open category against this advertisement.
- 6.14 It will be the responsibility of the selected candidates to submit all the required self attested copies of documents/certificates for proving his/her eligibility at the time of documents verification. The candidate will have to bring all original documents/certificates for verification, if selected. Failure to produce the same may lead to disqualification.

7. METHODOLOGY OF SELECTION:

- 7.1 The selection process shall comprise of On-line Test only.
- 7.2 All the candidates who registered successfully will be called for On-line test without verifying their eligibility. The verification of their certificates/documents/eligibility shall be done before issuing appointment. If candidate found ineligible/not eligible during verification process appointment order shall not be issued.
- 7.3 The On-line test will be of Objective Type Multiple Choice Test.
- 7.4 The On-line Test will include test of Marathi Language.
- 7.5 Taking into consideration the performance in On-line Test, select list will be prepared.
- 7.6 While drawing select list, out of 150 marks obtained in On-line Test will be converted into 100 marks. Thus, select/wait list will be drawn out of 100 marks.
- 7.7 Normally, selection process will be followed as prescribed above. However, which selection procedure is to be adopted will be at the absolute discretion of the Company and the decision of the Company in this regard shall be final.
- 7.8 There will be penalty for wrong answers. For each question for which a wrong answer has been given by the candidate, 1/4th (i.e. 0.25%) of the marks assigned to that question will be deducted as penalty to arrive at corrected score. If a question is left blank, i.e. no answer is marked by the candidate, there will be no penalty for that question.
- 7.9 For selection of Candidates under Horizontal Reservation:

In all such cases where a scribe is used, the following rules will apply:

- The facility of scribe is meant for only those candidates as mentioned above who have disability of 40 % or more and who have physical limitations to write including that of speed.
- Please ensure T you are eligible to use a scribe as per the Government of India rules governing the recruitment of Persons with Disabilities.
- The candidate will have to arrange his/her own scribe at his own cost.
- The scribe should be from an academic stream different from that stipulated for the post.
