General Instruction:

- 1. The applicant must be a Citizen of India.
- **2.** The Pay scale of post is as per the Central Government Pay structure as extended to C-MET and carry allowances as per Government of India orders issued from time to time.

- 3. If Legal Name of the candidate is same as that of name appeared on 10th Standard Certificate, then Candidate need not required to fill the Legal Name field. In case of change of name, the same document to be uploaded.
- **4.** Persons with given disabilities may apply against the above post and will be considered along with other candidates, if otherwise found eligible. (Physically handicapped (OA, OL, BL) Deaf and partially Deaf. **OA- One Arm, OL-One Leg, BL-Both Legs.)**
- 5. Those employed in Govt Dept/PSUs / Autonomous Bodies should submit their online application through proper channel within the closing date. Permission letter in this regard may be uploaded
- **6. Age Limit:** The age limit is reckoned as on the last date for receipt of application; i.e. 05.07.2022. The date for determining the upper age, qualification and / or experience etc. will be calculated as on closing date of application i.e. **05.07.2022**
- 7. Age Relaxation: (i)Upper age limit is relaxable for SC/ST 5 Years and for OBC 3 Years.
 - (ii) Up to 10 years in the case of PWD having minimum 40% disability.
 - (iii) Ex-servicemen by a period of service in any armed force plus three years. The benefit of age relaxation, who is already in Government civil employment on regular basis is permitted only for securing another employment in a higher grade.
 - (iv) Upto the age of 35 years to widows, divorced women and women judicially separated from their husbands who are not remarried (copy of Death Certificate of husband/certified copy of the judgment/decree of the appropriate court to prove the fact of divorce) to be attached.
 - (v) Five years relaxation to those who are already in Central/State Government, Central PSUs and Central Autonomous bodies and having at least three years regular service on permanent post.
 - (vi) Up to the age of 40 years to those who are already in the service of C-MET or any autonomous bodies of MeitY having at least three years regular service on a permanent post.
- **8. Application Fee:** Rs.500/- for General/OBC Candidates and Rs.250/- for SC/ST/PWD/WOMEN Candidates. Application fee is non-refundable.
 - a. The payment of the application should be made online only.
 - b. The payment will be received by Director, Science & Technology Park, Pune account on the behalf of C-MET, Pune.
 - c. Once the payment is made the same will not be refunded.
 - d. Payment service charges, if any, shall be borne by candidate only.
 - e. C-MET, Pune shall not be responsible for any incomplete/pending application.
 - f. For multiple payment transactions, if any, made by the candidate shall be refunded after verification from Bank Account

- **9.** Self attested copies of certificates / testimonials to be uploaded along with application form.
- **10.** Degree / Diploma shall be from a recognized University / Institution.
- 11. Candidates must ensure before applying the post that they are eligible according to the criteria stipulated in the advertisement. If the candidate is found ineligible at any stage of the recruitment processes, he / she will be disqualified and his/her candidature will be cancelled. Hiding of information or submitting false information will lead to cancellation of candidature at any stage of recruitment.
- 12. Selection to the post is purely on the basis of merit of written test. The final selection will be done amongst the qualifying candidates purely based on the marks obtained in the written test, in the order of merit only. There will be no interview. Syllabus and venue of the written test will be posted in our website. Candidates are requested to check C-MET Web site from time to time.
- 13. Mere fulfillment of the minimum prescribed qualification and experience will not vest any right of a candidate for being called for written test. If too many applications received than C-MET has full right to adopt any Screening criteria to get optimum number of candidates for selection test. The decision of the C-MET in this regard shall be final and binding on the Candidates. No correspondence in this regard will be entertained.
- **14.** Only short-listed candidates will be called for written test. Mere fulfilling of requirement as laid down in the advertisement does not qualify a candidate to be called for written test. No correspondence or interim enquiries in this regard shall be entertained.
- **15.** At present the place of posting will be as indicated in the advertisement. However, the persons selected shall be liable to be transferred to anywhere In India
- **16.** The decision of Director, C-MET, Pune in all matters relating to eligibility, acceptance or rejection of applications, mode of selection and conduct of examination/skill test will be final and binding on the candidates and no enquiry or correspondence will be entertained in this connection from any individual.
- 17. Travelling allowance: Candidates belong to SC/ST, person with disability mentioned at instruction Sl No. 4 and handicapped Ex-Servicemen are eligible for II class /sleeper class rail/ State Transport bus fare at actual on production of proof of travel if called for written examination in Pune region
- **18.** Any Corrigendum/corrections/modifications to the notification, syllabus for written test, examination centre, any other criteria for selection etc., will be notified only on C-MET web site. Candidates are advised to periodically visit C-MET web site. Neither C-MET nor any other agency will not make any correspondence and it is the responsibility of the candidates to see the web site for any updated information.
- 19. Canvassing in any form and or bringing in any influence political or otherwise will be treated as a disqualification for the post. No interim enquiry will be entertained. The candidates attempting to give false information/suppressing facts will be disqualified and are liable for debarment and /or legal action.

- **20.** Those working in Government / Semi-Government/ Public sector undertakings / Autonomous / Corporate Bodies shall upload a covering letter of their application which has been obtained as 'Through Proper Channel remark through their department.
- **21.** C-MET reserves the right to Revise/ Re-schedule/ Cancel/ Suspend/ Postpone/ Withdraw recruitment process without assigning any reason. The decision of C-MET shall be final and no appeal shall be entertained.
- **22.** Any legal proceedings in respect of any matter of claim or dispute arising out of this advertisement and / or an application in response there to can be instituted only in pune and courts / tribunals / forums at pune only shall have sole and exclusive jurisdiction to try any such cause / dispute.
- **23.** If any information furnished in the application by candidate found to be wrong or false, the candidate will be not allowed to participate in the selection process.
- **24.** The period of experience in a discipline / area of work, wherever prescribed shall be counted after the date of acquiring the minimum educational qualifications prescribed for that post. The period of experience rendered by a candidate on part time basis, daily wages, visiting/guest faculty will not be counted while calculating the valid experience for short listing the candidate for written test.
- **25.** Any document other than Hindi or English, a transcript of the document to be attested by Gazetted Officer or Notary is to be uploaded.
- **26.** The offer of appointment will be subject to verification of original certificates/ testimonials at the time of pre-appointment formalities otherwise the candidature shall be rejected.
- 27. In case of any inadvertent mistake in the process of selection, which may be detected at any stage, even after issuing of an appointment letter, the C-MET reserve the right to modify / withdraw / cancel any communication made to the candidate.
