Experience in audio / video production, knowledge of framework for developing web based project will be an added advantage.
Job requirement	Incumbent is expected to develop and curate online archive of Celebrating Indian Scientists from planning to execution. Content in the archive will be of text, illustration, audio / video. Support in various activities of the Science Media Centre (SMC), IISER Pune.
Tenure of the appointment	For a period of three months, extendable for further period subject to satisfactory performance of the incumbent.

**At the time of Walk-in interviews, applicants need to bring:**

1. Duly filled prescribed application form (available below advertisement link)
2. All the originals and one set of self-attested photocopies of:
  - a. Certificate regarding date of birth.
  - b. Mark sheets and certificates (starting from 10<sup>th</sup> onward) regarding educational qualification
  - c. All Certificate/s regarding experience/s as mentioned in the application form.
  - d. One Photo Identity proof (Government issued)
3. One recent passport size colour photograph.

**General Information / details about the post**

1. The appointment is purely temporary and will terminate automatically without any notice or compensation.
2. The appointed person shall have no claim of appointment / absorption in IISER Pune.
3. The qualification prescribed should have been obtained from recognized Universities / Institutions.
4. The prescribed educational qualification/s and experience/s are bare minimum and mere possession of same does not entitle candidates to be called for selection process. Where number of applications received in response to this advertisement is large, it may not be convenient or possible to carry out selection process for all the candidates. Based on the recommendations of the Screening Committee, the number of candidates to be called for the selection process may be restricted to a reasonable limit after taking into consideration qualifications and experience over and above the minimum prescribed in the advertisement. Therefore, it will be in the interest of the candidates, to mention all the qualifications and experience in the relevant field at the time of applying.
