- 1. Job Role: To cover Restructuring under Specific framework such as :
 - a. Covid impacted cases
 - b. Other cases permitted under RBI circular no. DR No. BP.BC.45/ 21.04. 048/ 2018-19 dated 07.06.2019 on Prudential Framework for Resolution of Stressed Assets and
 - c. Any other issues from time to time.
 - d. The role of such committee would be to validate the process of Restructuring i.e. providing additional comfort to lenders.
 - e. Committee is not expected to interfere in the commercial judgment of the lending institutions.
 - f. The validation exercise is to examine as to whether the proposal of restructuring is in line RBI circular no. DR No. BP.BC.45/ 21.04. 048/ 2018-19 dated 07.06.2019 on Prudential Framework for Resolution of Stressed Assets and any other guidelines issued from time to time.
 - g. All the accounts under Restructuring irrespective of their IRAC status will be covered under the purview of committee.
 - h. Proposal will be submitted to committee post sanction of the restructuring proposal by the concerned authority but before implementation.
 - i. Accounts above Rs 5.00Cr to Rs 500.00Cr.
