- 8) The selected candidates will be required to give an undertaking on stamp paper worth Rs.100/- that he/she will not leave job during the appointment period and shall complete the assignment and he/she will not claim for appointment on regular basis.
- 9) The candidates will be appointed for 11 month period (or less than that as per project duration).
