In case no candidate with above qualification then 02 years post MBBS experience with 01 year experience in concerned speciality will also be considered. Candidate must be enrolled with Delhi Medical Council. Candidate must not have completed 03 years SR in any Hospital under state Govt./Govt. of India including Regular or Adhoc Period
