## EMPLOYMENT ADVERTISEMENT

Applications are invited from eligible candidates to fill two (02) posts of Driver (General Category), purely on adhoc basis on consolidated pay of Rs.25,500/-i.e. initial pay scale of the post (as per the principle of Equal Pay for Equal Work) for the Additional District & Sessions Judge-I, Palwal & for the Chief Judicial Magistrate, Palwal, for a period of six months or till the regular appointments are made by the Hon'ble High Court, whichever is earlier.

The selection for the aforesaid post shall be strictly in accordance with amended Rule 7 of the Haryana Subordinate Courts Establishment (Recruitment and General Conditions of Service), Rules, 1997.

The Candidates, who are having below mentioned qualification, may submit their application in the office of District & Sessions Judge, Palwal, either by hand or by post.

### 1. AGE LIMIT

No person shall be recruited to the service by direct appointment, if he/she is less than 18 years or is more than 42 years of age as on 01.06.2023. Upper age limit is relaxable as per instructions of Hon'ble High Court and as prescribed by the Haryana Government from time to time.

### 2. Qualification:

- a) The candidate should be at least Middle Pass with Punjabi/Hindi as one of the subject.
- b) The candidate should possess a valid license for L.T.V.
- c) The candidate should not have been convicted for any offence for negligent driving.
- d) The candidate should have a minimum of two years experience of driving a car. The applicant shall possess a requisite experience certificate in this regard.

### 3. Disqualification:

No person:-

- (a) Who has entered into or contracted a marriage with a person having a spouse living or;
- (b) Who having a spouse living has entered into or contracted marriage with any person.

Shall be eligible for appointment to the service.

Provided that the committee, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage may exempt any person from the operation of this rule.

4. **Mode of Selection**

The candidates by conducting driving test to check the practical knowledge of driving skill/rules/signs. Final selection shall be based on driving skill test and Interview.

5. **LAST DATE:**

The Last Date for receipt of applications shall be **26.06.2023 upto 4.00 P.M.** No application received thereafter shall be entertained in any case. Delay on the part of postal authorities shall not be a ground for entertaining the applications received after due date.


6. **Date and place of Driving Skill Test and Interview:**

The date and schedule of Driving Skill Test and Interview as per the decision of the Recruitment Committee would be uploaded on the official website of this office i.e., <https://districts.ecourts.gov.in/palwal> in due course. The candidates are advised to visit the website regularly just after the last date of submission of application form. No separate call letters for Driving Skill Test and Interview would be sent to the candidates.

The applications, on plain paper with recent photographs of candidate affixed thereon containing full particulars i.e. Name, Father's Name, Date of Birth, Gender, Educational Qualification, Category, Permanent Address, Present Postal Address, Nationality, Contact Number, E-mail Id, experience certificate along-with self-attested copy of relevant certificates besides two self addressed properly stamped envelopes and the application should reach at below mentioned address by mentioning on top of envelope **"APPLICATION FOR THE POST OF DRIVER ON AD-HOC BASIS"** either by registered post or by hand well before the closing date i.e. **26.06.2023 upto 4-00 PM.**
