Applications are invited from eligible local candidates for filling up 01 (one) post of Principal, Sikkim Institute of Higher Nyingma Studies, Pangthang on temporary-regular basis in Level- 13A of the UGC Pay Matrix under Education Department, through Direct Recruitment. #### 2. ELIGIBILITY CONDITIONS:

## A. Minimum Educational Qualification:

- (i) Master's Degree (Acharya) in Buddhist Philosophy/Nyingma Philosophy with at least 55% marks or equivalent grade.
- (ii) Consistently good academic record
- (iii) Ph.D Degree
- (iv) 15 Years College or School teaching/administrative experience in due adherence to Notification No. 24/DIR(HE)/EDN dated: 21.12.2021

## B. Other Qualifications:

- (i) The candidate should have been conferred with the title of "Khenpo" by Nyingma Master like H.H. Kyabje Dodrubchen Rinpoche etc.
- (ii) The applicant must have done his Post graduation in Nyingma Philosophy from a recognized University.
  - (iii) The applicant must also have a Ph.D degree in Nyingma sect of Tibetan Buddhism in addition to having extensive knowledge in Sutra and Tantras.
- (b) Knowledge in any one of the local languages, viz, Sikkimese Bhutia, Lepcha, Limboo or Nepali

## C. Age Limit:

Should not have exceeded the age of 50 years (relaxable by 5 years for Government Servant) as on 31/07/2023, in terms of Notification No: 20/GEN/DOP dated: 15.06.1995

### D. Required Documents:

- (a) Candidate must be in possession of either Sikkim Subject Certificate or Certificate of Identification issued by the competent authority under relevant orders of the State Government.
- (b) Should have Valid Local Employment Card issued by the appropriate authority of the Government of Sikkim.
- (c) Marital Status certificate (for female candidate). In case of married women candidate, COI/SSC of Husband should be enclosed.
- (d) No Objection Certificate from the Head of Department in case of employed candidate.

- 3. Candidates who had applied earlier in response to the previous Advertisement no. 12/SPSC/Exam/21 dated:11/10/2021 are not required to apply.
- **4. SCHEME OF EXAMINATION:** Recruitment to the above posts would be conducted through **selection**.
- Candidate should go through the advertisement and read the instructions provided on the
  website carefully before applying online. Applications received through any other mode
  shall not be accepted and shall be summarily rejected.
- 6. The candidates are advised to apply online from our website <a href="http://spsc.sikkim.gov.in/">http://spsc.sikkim.gov.in/</a> on or before the stipulated date and time. Application submitted thereafter will not be accepted and SPSC shall not be responsible for the same.
- Application fee amounting to Rs 500/- only may be paid online through Net Banking or credit and debit card, (Visa/MasterCard). The amount once deposited shall not be refunded or adjusted against any other purpose.
- 8. E-Admit Cards can be downloaded and printed by the eligible candidates after a Notice for the same is published by the Commission in the official website of the Commission.
- Candidates are directed to bring a Photo Identity proof like (Aadhaar Card, Voters Card, Driving License) along with valid e-Admit cards in the examination centre for proof of identity.
- 10. Those candidates who qualify in the written examination will be called for the scrutiny of documents. Short listed candidates are required to submit attested Photocopies of all relevant documents on the dates specified by the Commission.
- 11. No TA/DA is admissible for attending the examination.
- 12. Admission to all the stages of examination for which candidates are admitted by the Commission viz. Written Examination shall be purely provisional and subject to satisfying the prescribed eligibility conditions. If, on verification at any stage of the examination process, it is found that candidates do not fulfil any of the eligibility conditions, their candidature for the post shall be cancelled by the Commission without notice
- 13. The Commission shall entertain application on review or RTI/Correspondence only after the entire process of recruitment is complete.
- 14. Any further instructions/Corrigendum/Addendum shall be uploaded only on Sikkim Public Service Commission website.
