Roles and Responsibilities of positions under the State Climate Action Cell

1. Climate Change Mitigation Expert

- 1) Support planning and implementation of climate change mitigation strategies, plans and projects.
- 2) Monitor and evaluate implementation of climate action plans.
- 3) Research, identify & help scale up various best climate change mitigation practices and potential innovations.
- 4) Research, development and streamlining of new and existing policies relevant to climate change.
- 5) Research, identify, pilot and help scale up climate change mitigation solutions primarily in the sectors of renewable energy, alternative fuel, waste to energy, pollution control, etc.
- 6) Liaising with all stakeholders including government departments & agencies (including Urban & Local bodies), potential partner agencies and institutions.
- 7) Help manage various climate change mitigation commitments of the state.
- 8) Promoting sustainable lifestyle activities for the citizens.
- 9) Explore and help spur climate innovations across the state.
- 10) Represent the state climate action cell in relevant forums, conferences, and meetings to foster knowledge exchange.

2. Climate Change Adaptation Expert

- 1) Provide direct implementation support for climate change adaptation strategies, plans and projects.
- 2) Lead and support technical tasks such as proposal and project assessments, quality control and field-level implementation.
- 3) Identify, adopt or develop decision making tools for climate-smart solutions.
- 4) Collaborate with expert institutes and knowledge partners for analysis and technical solutions.
- 5) Lead climate change adaptation solutions and project, primarily focusing on climate-resilient urban planning, climate proof infrastructure and green building development.
- 6) Liaising with all stakeholders including government departments & agencies (including Urban & Local bodies), potential partner agencies and institutions.
- 7) Ensure integrated planning of adaptation strategies plans and projects by engaging with relevant platforms, development partners, and public-private sector players for potential partnerships.
- 8) Help manage various climate change adaptation commitments of the state.
- 9) Conduct research on emerging environmental technologies and climate innovations and help them replicate across the state.
- 10) Represent the state climate action cell in relevant forums, conferences and meetings to foster knowledge exchange.

3. Climate Finance Expert

- 1) Establish and lead a State Climate Finance unit under the State Climate Action Cell.
- 2) Identify international, national and regional finance instruments and mechanisms and also pursue funding opportunities from various sources, including international climate funds, development banks, national and state schemes, private investors, and philanthropic organizations.
- 3) Stay informed about national climate policies, regulations, and international agreements related to climate finance. Closely follow and analyse national climate finance policies including national Carbon Credit & Green Credit frameworks, Green Bonds, Eco-mark certification, etc.
- 4) Conducting financial assessments of state's climate-related projects and initiatives to determine their feasibility and potential for attracting funding.
- 5) Help develop and implement strategies to attract public and private investments in climate-mitigation & adaptation projects, technologies, and innovations.
- 6) Collaborating with stakeholders, such as state government's departments, urban & local bodies and all state government owned entities, financial institutions, to enhance their understanding of climate finance mechanisms and build their capacity to access and manage climate funds effectively.
- 7) Promoting the development and uptake of green financial products, such as green bonds, climate-focused insurance, and sustainability-linked loans, to channel funds towards sustainable and climate-resilient projects.
- 8) Ensuring compliance with reporting requirements for climate finance projects, both to donors and regulatory bodies. This involves measuring and reporting on the environmental and social impacts of funded projects.
- 9) Assessing climate-related risks and integrating them into financial decision-making processes. This includes evaluating the physical risks associated with climate change and the transition risks stemming from shifts to a low-carbon economy.
- 10) Provide climate finance-based expertise in development and implementation of various climate change action plans, strategies and projects to state departments, urban & local bodies and all state government owned entities.

4. Consultant/ Project Officer

- 1) Develop, implement & manage national and state strategies, plans and projects aimed at mitigating climate change, climate resilience, or promoting sustainability.
- 2) Align various State projects with broader environmental and climate change strategies at local, regional, or global levels.
- 3) Collaborate with relevant government departments & agencies (including Urban & Local bodies), non-governmental organizations (NGOs), community groups, knowledge partners and other stakeholders.
- 4) Assist in the development and on-field implementation of environmental and climate change policies, strategies, and action plans.
- 5) Hold effective communication and engage with stakeholders to gather inputs, address concerns, and build consensus on environmental and climate-related initiatives.
- 6) Promote sustainable practices and encourage the adoption of climate and eco-friendly initiatives in various climate relevant sectors like energy, agriculture, transportation, housing, water and urban planning.
- 7) Raise awareness about climate change impacts and solutions through educational campaigns and public outreach activities.
- 8) Conduct research on emerging environmental technologies and climate innovations and help them pilot and replicate across the state.
- 9) Engage with national and international organizations, forums and represent the State at various regional, national & international conferences to stay connected with the global environmental and climate change community.
- 10) Cooperate, associate, and help streamline state knowledge management platforms.
