 - (vi) A minimum standing of 10 years as an Advocate is required for considering an Advocate for CBI Special Public Prosecutor (Subordinate Court), who have experience in handling criminal matters.
 - 4. PERIOD- Minimum 03 years.
 - 5. NATURE OF JOB: To conduct cases in the Trial Court, Indore, Madhya Pradesh.
