1. CBI, ACB, Mumbai intends to engage Special Public Prosecutors to conduct CBI Cases in Special Courts situated at various districts of Maharashtra, Silvassa and Daman (U.T.). In this regard, applications are invited from the eligible advocates for engagement as Special Public Prosecutor in CBI to conduct CBI Cases in various Courts situated at Thane, Kalyan, Belapur, Amalner, Nandurbar, Malegaon, Dhule, Nasik, Bhusawal, Jalgaon, Uran, Vasai, Palghar, Ratnagiri, Sindhudurg & Alibaug, Maharashtra, Silvassa & Daman (U.T.).
2. **PROFESSIONAL FEE** : The professional fee of the Advocates will be governed by the terms and conditions contained in DoPT F. No. 225/19/2023-AVD- II dated 08.04.2024 (Copy Enclosed).
3. **ELIGIBILITY CRITERIA** : The following points may be kept in view while submitting the request for the appointment/engagement of CBI Special Public Prosecutor to conduct CBI Cases before the Hon'ble Courts :
 - i. Educational Qualification : LLB
 - ii. Enrollment Certificate as an Advocate with the Bar Council.
 - iii. Experience at BAR of handling Criminal matters in Sessions Courts.
 - iv. An unconditional willingness/consent to work on the general terms and conditions approved by Government of India from time to time.
 - v. Details of important cases handled by the applicant Advocates.
 - vi. A minimum standing of 10 years as an Advocate is required for considering an Advocate for CBI Special Public Prosecutor, who have experience in handling Criminal Matters.
4. **PERIOD** : Minimum 03 years.
5. **NATURE OF JOB** : To conduct trial of all CBI cases pending in above courts.

Out of Headquarters	<p>If the Counsel is required to go out of Headquarters in connection with conducting the CBI cases e.g. for appearance in court outside the Headquarters, he will be entitled to a daily fee of Rs. 1000/- per day for the days of his absence from the Headquarters including the days of the departure from, intervening holidays and arrival back at the Headquarters.</p> <p>Provided that no fee will be paid for the day of departure if he leaves the Headquarters after court hours or for the day of arrival if he arrives at the Headquarters before the court hours.</p>

Travel/Hotel Expenses	In addition to the daily fee, the counsel will also be entitled to travel expenses for travel by air (economy class)/AC-II tier or first class by train, road mileage for the journey from his headquarters to the airport/railway station and vice-versa and from the airport./railway station to the place of his stay out of Headquarters and vice-versa at the rates admissible to the Group A Gazette Officer of the Central Government, he will also be paid conveyance charges for performing local journey while outside the Headquarters at the rates as admissible to the Group A Gazetted Officer subject to a maximum of Rs.338/- per day. he will also be entitled to a reasonable actual expense for stay in Hotel at the rates as admissible to the Group A Gazetted Officer subject to a maximum of Rs.2250/- per day in terms of instructions issued by the Ministry of Finance from time to time.
3.	Clerkage	The Counsel will be entitled to 10% of fees subject to a maximum of Rs. 1800/- in a case or batch of cases by way of Clerkage.
4.	Out of Pocket Expenses	The amount required for court fees at the time of filing a case; and other miscellaneous expenses not exceeding Rs. 750/- should be obtained by the counsel in advance from the concerned branch/unit of CBI on whose behalf the Counsel will conduct the cases in the trial court. An account of the expenses incurred should be rendered to the concerned branch/Unit while presenting the final fee bill.


