### NOTICE FOR WALK-IN-INTERVIEW

A <u>Walk-in-Interview</u> will be held on 18/6/2024 from 10.00 a.m. onwards at ICAR-Central Institute for Research on Cattle, Grass Farm Road, Meerut Cantt (UP) for the engagement of the YP-II in ITMU/NAIF Section of this Institute as per details below. The engagement is purely temporary on contractual basis under the ICAR guidelines as communicated from time to time and there will be no provision of absorption/re-employment in the CIRC/ICAR. The positions are sanctioned initially for one year from the date of selection/joining, however the tenure is extendable upto further period of next two years (one year at a time) based on need and performance of the candidate.

The eligible candidates should attain the minimum 21 years of age but should not be above 45 years of age on the date of advertisement. The consolidated emoluments for the position of Young Professional-II (YP-II) are Rs. 42000/-per month (fixed). Other terms and conditions issued from ICAR from

#### **Selection Procedure:**

a. For each requirement/position of YP, at least <u>five applications</u> shall be shortlisted based on their qualifying academic performance and experience. These shortlisted candidates will undergo a panel interview. <u>In case of tie at any stage all the candidates who have same marks will be considered to have qualified for further rounds.</u>

<u>Guidelines/Other terms & conditions for the candidates/applicants:</u> The positions are purely temporary and on contractual basis. The services on the above positions will stand terminated automatically after the expiry of the contract period (Project/Scheme) or subject to requirement of the services of the YP in the organization and satisfactory as indicated in the offer/letter after selection or till further orders from the Council in this regard.

- 1. The selected candidates have no right for absorption/regular appointment in CIRC/ICAR.
- 2. The leave and other benefits, if any, will be governed as per existing norms of CIRC/ICAR.
- 3. The appointment will be subject to the condition that the candidate is declared medically fit for service by the medical authority i.e. Civil Surgeon/Chief Medical Officer.
- 4. In case the candidate after appointment & joining wish to resign from the position before expiry of contract, he has to submit a notice giving one month time or should deposit one month pay in view of immediately relieving.
- Leave and Other terms & conditions of the service will be governed by the relevant rules and orders from time to time by CIRC/ ICAR.
- The candidates should ensure their eligibility for the post before applying. Only those candidates having the essential educational qualification will be interviewed.
- 7. No TA/DA will be paid to the candidates for attending the interview/test and/or joining the position etc.
- No objection certificate' and experience certificate (as the case may be) have to be submitted by the candidates from the present employer, if the candidate is employed elsewhere at the time of interview.
- 9. The applicant should bring certified copies of all related documents alongwith application form at the date of interview.
- 10. The candidates must bring with them all the original certificates for verification at the time of Interview.
- 11. Age will be reckoned from the date of advertisement.
- 12.CIRC reserves the right to increase/decrease the number of vacancies as per requirement.
